Patron Acknowledgement Form: COVID-19

_____ a. In support of updated Centers for Disease Control and Prevention (CDC) guidelines, fully vaccinated personnel (who are at least two weeks beyond their final dose) are no longer required to wear a mask indoors or outdoors at DoD facilities. Personnel who are not fully vaccinated should continue to follow applicable DoD mask guidance, including continuing to wear masks indoors. Social distancing, sneeze guards, and posted policies around the facility will be observed.

_____ b. Two grab and go style breakfast boxes will be available Monday- Friday and a hot breakfast plate will be available on Weekends and Holidays during normal operating hours. Indoor dining with limited capacity and outdoor patio spaces are available during breakfast hours.

_____ c. Daily Housekeeping Stayover Services have been suspended. Housekeeping Stayover Services will be offered to patrons every seventh day. Additional complimentary guest items can be obtained from the hours of 0600-1300 at the Front Desk. **Trash and linens may be placed outside your room from the hours of 0600-1300.** In order to maintain the cleanliness around the property **trash and linens will not be placed outside of the rooms outside of the hours listed in line item "d."**

_____ d. If utilizing Express Check-Out, a call to the front desk is required upon your departure or no later than the check-out time of 1100. I am aware that I will receive an emailed copy of my receipt.

_____ e. The playground will be open each day between the hours of 0800-1800. I and any additional guest(s) under my reservation will adhere to the following:

- _____ Adhere to a daily closure requirement from 1300-1400 to allow staffing the opportunity to properly sanitize the equipment/ area.
- _____ Utilize the hand washing station before and after entering the playground.
- _____ Adhere to all posted signage in and around the area.

_____ f. If utilizing an Inns of the Corps Fitness Center, a call to the front desk is required to reserve a 45-minute time slot. The Fitness Center will be open each day between the hours of 0500-2000. I and any additional guest(s) under my reservation will adhere to the following:

- _____ **If applicable**, wearing a face mask during use.
- _____ Keeping the fitness center door open.
- _____ Checking out and returning the fitness key before and after use.
- _____ Utilizing the provided cleaning solutions to sanitize each machine or piece of equipment after use.

_____ g. I have answered the health assessment screening questions. If applicable, I have received the restriction of movement (ROM) requirements for the facility. I am aware that the ROM is required for 14-days or the length of stay, whichever comes first.
